Sales are on a cash basis. In transactions where livestock are to be delivered at a later date, payment shall be in accordance with the contract. If purchases are not paid as specified, the unpaid balance of my purchase will bear interest at the statutory rate until paid in full. If the Okeechobee Livestock Market takes legal action to collect my account and prevails, the Okeechobee Livestock Market shall be entitled to reasonable attorney's fees and court costs.
