Sales are on a cash basis. In transactions where livestock are to be delivered at a later date, payment shall be in accordance with the contract. If purchases are not paid as specified, the unpaid balance of my purchase will bear interest at the statutory rate until paid in full. If Producers Cattle Auction takes legal action to collect my account and prevails, Producers Cattle Auction shall be entitled to reasonable attorney's fees and court costs.

I UNDERSTAND AND AGREE THAT THERE ARE NO IMPLIED WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE ON LIVESTOCK SOLD.

I hereby grant Producers Cattle Auction a security interest in all livestock that I purchase from/at/through Producers Cattle Auction, as well as all proceeds there from, until Producers Cattle Auction, LLC has received final payment and authorize Producers Cattle Auction to authenticate and file any and all documents that are needed to perfect and give notice of Producers Cattle Auction's interest in such livestock.

I hereby authorize Producers Cattle Auction or its agent Livestock Marketing Association to contact the above-named bank(s) for information concerning my financial responsibility and authorize the above-named bank(s) to release to Producers Cattle Auction or Livestock Marketing Association information necessary to determine my financial responsibility and/or ability to pay for livestock.
